Ningbo Shanshan Co., Ltd.

Announcement on the release of pledge of partial share for non-public offering of convertible corporate bonds by the controlling shareholder

Important Notice:

● Shanshan Group Co., Ltd. (“Shanshan Group”) holds 782,222,036 shares of Ningbo Shanshan Co., Ltd. (“the Company”), including 5.99 million shares for securities lending, accounting for 34.94% of the total share capital of the Company. After the release of 20,000,000 shares pledged, Shanshan Group holds 542,863,870 shares of the Company pledged, accounting for 69.40% of the total shares of the Company it holds and 24.25% of the total share capital of the company.

On September 10, 2022, the Company disclosed the [Ningbo Shanshan Co., Ltd. Announcement on Share Pledge for Non-public Offering of Convertible Corporate Bonds by the Controlling Shareholder](#) on the Company Website. Shanshan Group has pledged 80,000,000 unrestricted outstanding shares of the Company to LC Securities Co., Ltd before the issuance of non-public offering of convertible corporate bonds (the second tranche, 2022) to professional investors, and transferred these shares to the “Shanshan Group Co., Ltd. - Special pledge account for non-public offering of convertible corporate bonds (the second tranche, 2022) to professional investors”. The starting date of pledge is September 8, 2022. The purpose of pledge is to provide guarantee for the exchange of shares by bondholders and the repayment of the current bonds.

At present, the Company has received the notice from Shanshan Group. In accordance with relevant agreements and guarantee situation of the Bonds, the partial shares (20,000,000 shares) of “Shanshan Group Co., Ltd. - Special pledge account for non-public offering of convertible corporate bonds (the second tranche, 2022) to professional investors” have been released from pledge and transferred to the account of Shanshan Group, and the pledge release registration procedures have been completed at China Securities Depository & Clearing Corporation Limited Shanghai Branch.
